**The Christ Central Ministries Statement of Faith** and Principles is a broad evangelical declaration that closely parallels the content of the Gospel presentation and the concepts considered vital for the furthering of this ministry. All persons seeking to serve in a leadership, ministry or teaching role in this ministry are required to concur with this statement. It is the intent and desire of this ministry to display respect for all denominations and to allow for freedom of conviction on doctrinal interpretations, provided that any interpretations is based upon the Bible alone, and that no such interpretation shall become an issue which hinders the ministry to which God has called each of us to do.

1. We believe that there is only one God, eternally existent in three persons: Father, Son and Holy Spirit. (Genesis 1:1, John 10:30, 37 & 38)
2. We believe the Bible is the inspired, infallible, inerrant, and authoritative Word of God. (II Timothy 3:16, II Peter 1:21)
3. We believe in the deity of Christ, His virgin birth, His sinless life, His atoning death through His shed blood on the cross, His bodily resurrection, His ascension to the right hand of the Father, and His personal return in power and glory. (Luke 23:44-46, 24:5 & 6; John 5:28 & 29)
4. We believe that through the crucifixion, death, and resurrection of Jesus Christ alone, every power and penalty can be removed that would keep us from communion with God and glorification in heaven. This is salvation. (John 3:16-19 & 5:24, Romans 3:19 & 23)
5. We believe that God is indwelling today, being worthy of worship alone, having created all things from nothing, visible and invisible, through and for His sovereign plan. (Genesis 1:26-28, 5:1 & 2)
6. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life and they that are lost unto the resurrection of eternal separation from God. (Matthew 13:30, 40-43; 25:46; John 5:29; 2 Corinthians 5:10)
7. We believe in the spiritual unity of believers in our Lord Jesus Christ. This is the fellowship of God's Church and Body of Christ. (Romans 8:9; 1 Corinthians 12:12 & 13; Galatians 3:26-28)
8. We believe children are a gift from God and it is our responsibility to teach them scriptural principles, godly character and biblical convictions, bringing them up in the discipline and instruction of the Lord. (Deuteronomy 6:5-9; 11:18-21; Psalm 27:3-5; Proverbs 22:6 & 23:13 & 14)
9. We believe that the primary evidence of one "in Christ" is revealed in their love for God and their love for others (John 13:34-35)
10. We believe that a person "in Christ" must respond to the leading of the Spirit of God to minister hope and help to the poorest of the poor of all nations. (Philippians 2:1-4; I Corinthians 13)
11. We believe in the present ministry of the Holy Spirit, by whose indwelling enables the Christian to live a godly life. (John 4:16-18; 16:13-15; Romans 8:26-27; Philippians 1:6)
